Agistix, Inc. places the utmost importance on protecting your privacy. We believe that you have a right to know our practices regarding the information we may collect and use when visiting our website. This privacy notice explains what types of information are collected by our website (<https://www.agistix.com/>) and how this information is used.

Privacy Acknowledgement

BY INTERACTING WITH OUR WEBSITE—INCLUDING ENTERING, CONNECTING TO, ACCESSING, OR UTILIZING ANY INFORMATION CONTAINED WITHIN—your use of the website constitutes your explicit consent to the collection, use, disclosure, retention, and disposal of your personal information as outlined in this notice.

We ensure that:

- Your consent is freely given, specific, informed, and
- You are aware that you may withdraw your consent at any time, with the understanding that this will not affect the lawfulness of processing based on consent before its withdrawal
- The process to withdraw consent is as easy as the process to give
- Where we rely on your consent to process personal data, we will always request it via a clear affirmative act, such as the ticking of a box, or another statement or conduct which clearly indicates in this context your acceptance of the proposed processing of your personal data.

Who We Collect Information From

While we are a business-to-business company we process personal information of various categories of individuals in order to function and to maintain relationships with these individuals and their organizations. We process the personal information of the following individuals:

- Platform Users
- (Website) Visitors
- Microsite Users
- Employees, contractors, and applicants
- Other individuals, we connect with professionally

Information Collected

In the course of our business activities and providing our Services, we process personal information that you provide directly or indirectly to us when using our Services or interacting with us in any other situation, including:

- **Identification information**, such as your name, online identifier, signature in case of contracting, login credentials, IP address;
- **Contact information**, such as your email address, phone number, work address, business card,
- **Professional information**, such as your job title/position, employer;
- **Usage information**, such as geolocation, traffic data, logs, error and crash reports, and other communication data and the resources that you access and use through our Services and how you use them, including session time and navigation journey;
- **Location information** (only when you enable location sharing on your device while using Microsites),
- **Device information**, such as device's hardware model, operating system version, unique device identifiers, browser type, and mobile network information; and
- **Other information you choose to provide to us**, for example the purpose of your visit when you visit our office, your photo when you update your profile, or any other information when using our contact forms.

Agistix provides its service to its customers subject to the agreement by which you have gained access to the shipping services and this Privacy Policy, which shall be deemed part of such agreement. Customers are required to provide us with contact information (including their name, e-mail address, and phone number) as well as information about their company. This information is necessary to provide the Agistix service to customers.

We may also use the information to contact customers and prospects to further discuss their interest in our company, the services we provide, and ways we can improve them, as well as to send information such as announcements of promotions and events regarding our company or partners. We may also e-mail a customer newsletter and updates about the services, Agistix, or its partners. All contacts have the right to unsubscribe to these communications at any time.

Agistix does not distribute or share customer e-mail addresses or other contact information except as noted in its Terms of Service or as may be required by law.

We do not disclose the information provided to any third party, although we may provide this information on an anonymous, aggregated basis to vendors, customers, and partners as part of our service offering.

Other third parties, such as content providers, may provide information on an Agistix website, but they are not permitted to collect any information, nor does Agistix share any personally identifiable user information with these parties.

Technical Issues

All communication on the Internet takes place between pairs of IP Addresses. We collect IP addresses and technical data such as browser type and operating system for troubleshooting, website administration, and to gather broad demographic information. This data helps us ensure the compatibility of our website with user platforms and to understand our user base more completely.

Cookies and Automated Technologies

Cookies and similar technologies are used to enhance user experience and provide better service, for performance analytics, and for targeted advertising. Specific uses include:

- Personalizing user experience based on past usage (including saving your encrypted login information and password on your device if you actively select this option)
- Analyzing website traffic and usage
